# COMMUNITY ENVIRONMENTAL MONITORING PROGRAM TO BE INTRODUCED Superior Watershed Partnership Seeks Public Input at Upcoming Town Hall Meetings

## Marquette, MI - November 28, 2012

The Superior Watershed Partnership is hosting a series of town hall meetings to introduce the Community Environmental Monitoring Program (CEMP) that will conduct an on-going, independent assessment of the Rio Tinto Eagle Mine and report findings to the public.

Under the cooperative agreement announced in October, Rio Tinto is providing the Marquette County Community Foundation with funding (\$300,000 annually) to establish and oversee independent program to conduct environmental monitoring related to mining operations. SWP staff will coordinate and implement the program working with universities, contractors and EPA approved laboratories to evaluate the Eagle Mine, the Humboldt Mill and transportation routes. Monitoring will include verification of Rio Tinto's permit requirements for air quality, groundwater, surface water, wildlife, plant life as well as additional monitoring of other potential impacts. The CEMP is also designed to accept third party funding to expand monitoring if needed.

SWP/CEMP Town Hall Meetings are distinct from previous community forums held by Rio Tinto. Members of the public, community organizations, tribes and others are encouraged to attend to learn more about the program, ask questions and provide recommendations for additional monitoring. Additional town hall meetings will be held quarterly in 2013 to report to the public and seek additional input.
